## Executive Summary

Work Package 5 is all about the ClusterXchange program. The ClusterXchange program supports short-term exchanges to better connect Europe's industrial ecosystems. The general objective of ClusterXchange is to encourage and facilitate transnational, cross-regional, sectoral and cross-sectoral cooperation between clusters and their members to boost their learning and innovation-oriented activities with the view to increase the competitiveness of European SMEs. ClusterXchange is already in its 4<sup>th</sup> Generation (2020) in term of European Strategic Cluster Partnerships. One of these partnerships is ours: REMOBILISE. With this project we have access to the ClusterXchange program and we offer to all of our partners the opportunity to join and to broaden their horizon within Europe.

This report will show the advancement of REMOBILISE ClusterXchange exchanges after one year of implementing the actions: activities, matching relationships, problems encountered, solutions implemented, and resources spent. This report will especially seek to show the alignment with the ClusterXchange methodology, from the promotion of the program to the follow-up after the exchanges, including the enrolment of participants, the exchanges preparation and the exchanges themselves. This report will be used as a periodic validation of the activities and provide the opportunity to improve the scheme if needed.

This report is divided in multiple sections. In chapter one we discuss our experiences concerning ClusterXchange from the perspective of the five different clusters within REMOBILISE. Subsequently, in chapter two we discuss which activities have been carried out for the promotion of ClusterXchange and the ClusterXchange IT tool. Then, we discuss the next steps until the end of our project (M24) we will perform to communicate and work with ClusterXchange and its tool towards our SMEs, scale-up supporting organizations and other cluster organizations. Finally, our measurable significant results will be communicated.

## Issues and Problems

The ClusterXchange programme is not new to this consortium. REMOBILISE is a continuation of the initial RECIPE4Mobility partnership (ESCP-4x). During the period of this partnership, a lot of experience was gained with ClusterXchange, the CXC Support Office and the CXC IT tool. Mainly because of COVID-19, there have been many issues with the implementation of the support program. However, considering the time that was left after COVID-19 back then, we were able to end the RECIPE4Mobility partnership with 27 exchanges in total within a timeframe of less than a year. Therefore, the REMOBILISE partnership embarked on ClusterXchange with great confidence from past experience.

But the REMOBILISE partnership believes that the initial ClusterXchange IT tool is not user friendly and it takes a lot of effort and time to fill in all the necessary steps in order to start and create an exchange between an HO and VO. Therefore, asking external companies to create profiles and fill it out might be too demanding unless we provide something in exchange for their efforts.

But on 20 September 2022, we received notification from the CXC Support Office that a new CXC IT tool has been launched. This can only be accessed if you are an administrator. It is them who create the exchanges and, once they have filled in the information about the HO and VOs, the HO and VO administrators will have access to the CXC IT Tool. We think this is a huge step in the right direction. It saves a lot of time, especially for the HO and VO, and it gives the REMOBILISE partnership a more significant role as 'coordinator' until exchanges are set up.

However the exchanges encoded in the 'old' CXC IT Tool have not been transferred to the new one. This was unfortunate, because in our case we had to re-enter a number of exchanges. A small effort for the greater good. In addition, we were told on 30 September 2022 that there are still some bugs in the new tool. In particular, this has to do with linking the IT tool to the ECCP website. There were also problems with saving draft (group) exchanges. The CXC Support Office was actively contacted about both problems. However both problems unfortunately could not be resolved in the short term. It resulted in us organising most of the REMOBILISE exchanges without the IT tool. On the advice of the CXC Support Office, we therefore shared the Commitment to Quality, Financial Agreement and Final Activity Report documents by email with the HO and VO parties involved. This was very much helped by the CXC Support Office. So it also means that these exchanges did not get a unique ID from the IT tool. An overview of all exchanges can be found in the appendix on page 20.

So unfortunately, we have gained minimal experience from the new IT tool. This is unfortunate. But at the same time, despite the problems with the tool, we have found a good way to realise as many exchanges as possible. Hopefully, the tool will be operational in the second year of the REMOBILISE partnership so that we can gain experience with the new tool.

### CXC Satisfaction Survey

This survey intends to measure the satisfaction of the European Cluster Partnerships | Excellence with the ClusterXchange programme and, more specifically, the CXC Support Office (CXC SO)'s performance. The REMOBILISE partnership successfully submitted the survey on 15 December.

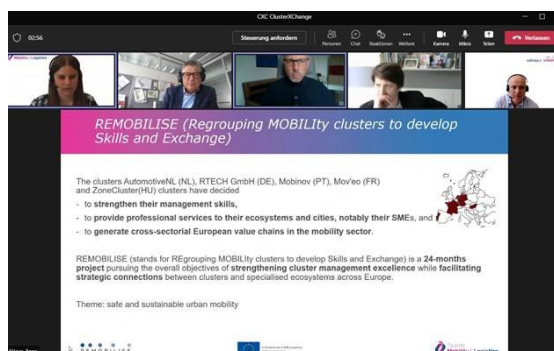

## Brief introduction ClusterXchange

### What it is supported?

- Short-term exchanges (three working days to one month) for transnational cooperation, learning, networking and innovation-oriented activities between the participants

### Use

- Learn from actors in another cluster
- Explore growth opportunities in new markets
- Take up new technologies
- Invest in strategic interregional collaboration.

### Main Requisites:

- All participants to come from COSME participating countries
- All exchanges to be cross-border: host and visiting organisations registered in two different eligible countries
- Each eligible organisation may benefit from the scheme only once as a visiting organisation per generation.
- The amount of financial support per third party (visiting organisation) must not exceed the threshold per host country.
- Host & visiting organisation distance  $\geq 200$  km

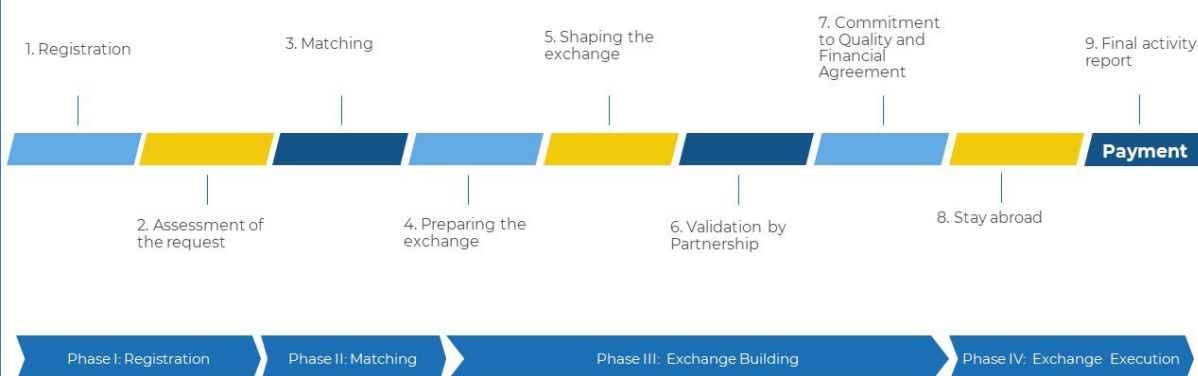

Register for free on the **ECCP portal**, and gain access to the **Clusterxchange platform**. You will then create your exchange profile, with this information:

- **Visitor or Host:** (Only one physical exchange as a visitor per organization; no limit of exchanges as a host)
- **Organization:** name, legal form, sector, pole of affiliation, address and website, description of the activity
- **Exchange participant** (preferably a manager): name, position, languages spoken, e-mail and telephone, CV (free format/language)
- **Preferences:** range of availability, duration of the exchange, type of organization targeted (cluster, SME, gas pedal...), countries and sector targeted, languages spoken, type of exchange (exploring new markets, learning...)
- **Motivations:** Why do you want to participate? What can you bring to this exchange?
- **Reference partnership:** as a mobility company, please inform RECIPE4Mobility, the partnership coordinated by Mov'eo

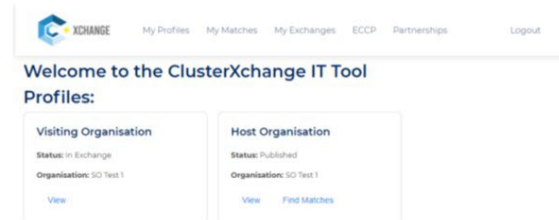

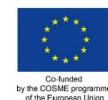

## Next steps

Our goal is to use ClusterXchange to register during the remaining two Cluster Missions in Portugal (Porto) and Hungary (Boedapest). Also, we want to make use of the ClusterXchange program for bigger international fairs such as the JEC in Paris and the Solutrans fair in Lyon. Furthermore we will still remain to promote ClusterXchange and the ClusterXchange IT tool via our newsletters, mailings to cluster-member and introducing it at other events. Hopefully this will increase the numbers of registrations.

## Significant results

In the table below you will find our targets in term of number of exchanges specified in our Grant Agreement on the left and on the right the status after M12 (January 2023).
